# Daniel Clearfield

## MEMBER

Dan Clearfield's energy-related practice is concentrated in the areas of utility, energy, and communications regulatory litigation; alternative energy development and regulation; shale gas drilling and mid-stream issues; administrative litigation; and government relations. He regularly represents a variety of distributed energy and generation providers providing regulatory and legal advice for solar, landfill gas, LNG hydrogen and RNG projects.

Dan represented the then leading alternative energy supplier in the enactment and implementation of Pennsylvania's electric and natural gas restructuring legislation, which brought greater choice and competition to Pennsylvania's retail electric and natural gas markets. He also represented electric suppliers in the implementation of electric choice in several other Mid-Atlantic states and New England. Today he regularly counsels electric and natural gas suppliers in Pennsylvania and in several other states.

Dan has also counseled natural gas exploration, production and midstream companies on a variety of Pennsylvania regulatory issues and was one of the firm's representatives on the Marcellus Shale Coalition.

Regarding controlled substances, Dan has represented a number of medical marijuana license applicants and counsels business on Pennsylvania medical marijuana regulatory rules. He was previously a member of the PBA Medical Marijuana and Hemp Law Committee.

Prior to entering private practice, Dan served as Executive Deputy Attorney General and head of the Public Protection Division in the Pennsylvania Attorney General's Office and as Senior Assistant Consumer Advocate in the Pennsylvania Office of Consumer Advocate. Clearfield received his B.A. from Temple University, *magna cum laude*, in 1974 and his J.D. from Temple University School of Law, *cum laude*, in 1977 where he served as an editor of the Law Quarterly.

Clearfield is the author of numerous articles and commentaries in the areas covered by his practice.
