## REPRESENTATIVE MATTERS

- Argued before the Massachusetts Supreme Judicial Court and obtained a unanimous 70-page opinion affirming a successful trial court result protecting a client's treatment program from government bad faith conduct. *Judge Rotenberg Educ. Ctr., Inc. v. Comm'r of Dep't of Developmental Servs.*, 492 Mass. 772 (2023).
- Argued before the U.S. Court of Appeals for the District of Columbia Circuit, and successfully vacated a device ban promulgated by the U.S. Food and Drug Administration. *Judge Rotenberg Educ. Ctr., Inc. v. FDA*, 3 F.4th 390 (D.C. Cir. 2021); *Judge Rotenberg Educ. Ctr., Inc. v. FDA*, No. 20-1087 (D.C. Cir. Nov. 22, 2021) (order denying petition for rehearing en banc).
- Lead trial attorney in a forty-four day trial against the Commonwealth of Massachusetts and the Massachusetts Attorney General's Office, defeating the Commonwealth's attempt to vacate a Consent Decree that protects a residential education and treatment program and its clients from government bad faith. *Judge Rotenberg Educ. Ctr., Inc., et al. v. Comm'r of the Dep't of Dev. Servs., et al.*, No. 86E-0018-GI (Mass. Prob. Ct. June 20, 2018).
- Successfully obtained a preliminary injunction in U.S. District Court requiring the Washington, D.C. Department on Disability Services to immediately remove a client from a psychiatric hospital and place him in a community-based program. Secured permanent funding for the client in a community-based program.
- Successfully defended clients in investigations conducted by the U.S. Department of Justice, Massachusetts Attorney General, U.S. Food and Drug Administration, Massachusetts Division of

Occupational Licensure, Massachusetts Department of Children and Families, Massachusetts Department of Developmental Disabilities, Massachusetts Disabled Persons Protection Commission, and many other federal and state agencies.

- Lead trial attorney in a four-week trial against the Massachusetts Attorney General's Office successfully resulting in contempt findings against the Commonwealth of Massachusetts and a court order placing a state agency into receivership for the first time in Massachusetts history. Successfully defended the contempt and receivership judgment in the state's appeal to the Massachusetts Supreme Judicial Court. *Judge Rotenberg Educ. Ctr., Inc. v. Comm'r of Dep't of Mental Retardation*, No. 86E-0018-GI (Mass. Super. Ct. Oct. 6, 1995).
- Advises hundreds of businesses on regulatory compliance, employment matters, business disputes, crisis management, media relations, subpoenas, leases, licenses, permitting, and many other business-related legal issues.
- Advises nonprofits on governance, regulatory compliance, medicolegal issues, legislative issues, ADA protection, insurance issues, and malpractice defense.
- Lead trial counsel in defending a bank in a lender liability case resulting in a judgment of dismissal of all claims against the bank.

New York Dep't of Educ.*, 2006 WL 8452655 (N.D.N.Y. Sept. 8, 2006)

- Court appointed to represent a wealthy incompetent individual suffering from Alzheimer's, and after a two-week trial as lead counsel successfully recovered all of the client's assets which she conveyed prior to her guardianship.
