In his intellectual property practice, Trevin represents clients in complex disputes involving patents and trade secrets across various industries and technologies, including cases involving trade secret misappropriation, patent infringement, and challenges to the validity of patents. Employment Litigation and Advice. Consumer Financial Services. Trevin has handled a broad range of responsibilities within these disciplines, including overseeing pre-suit investigations, product and/or automotive/motorcycle inspections, as well as handling all aspects of the litigation itself, including complex discovery and depositions.
