# Renée Martin-Nagle

Renée Martin-Nagle divides her energies between the firm's nationally-recognized aviation practice and the environmental law practice.

She joins Eckert Seamans after serving as CEO and President of A Ripple Effect plc, a consultancy focused on international water law and integrated water resources management services. Her work at A Ripple Effect included designing a sustainability program for a major U.S. airline, producing an analysis of sustainability initiatives at smaller U.S. airports for the U.S. Airport Cooperative Research Program, drafting the official synopses of international water conferences in Bonn and Abu Dhabi for OOSKANews, and developing summaries of water laws in Nigeria, Mongolia, Bangladesh, Somalia, Zambia, and Ghana for the Center for Water Security and Cooperation. She has taught international environmental law and policy at the University of Pittsburgh School of Law and the University of Strathclyde in Glasgow, Scotland. She is currently teaching international environmental policy as an adjunct professor at St. Francis University.

Prior to her environmental career, Renée served for more than 20 years at Airbus Americas, retiring in 2011 as Vice President, General Counsel, Chief Compliance Officer, Head of Environmental Affairs, Corporate Secretary, and a member of the board of directors. While at Airbus, she designed and implemented policies, programs, and training concerning corporate compliance, lobbying, document management, export-import regulations, business ethics, environmental issues, and social media. She acted as sole Airbus lawyer in numerous, highly complex sales contracts, led a team that developed and implemented an ISO 14001 program in North America, and established formal and informal environmental programs at all U.S. facilities. Among her many aviation sector activities, Renée served as chair of the American Bar Association Forum on Air and Space Law. She was honored with the 2014 Aviation Industry Woman of Excellence Award by the International Aviation Women's Association.

Renée focuses her environmental and sustainability work on freshwater, with a particular emphasis on the governance and hydrogeology of groundwater aquifers, ecosystem protection, and interspecies equity. She has published books and articles on these topics, and reviewers have called her 2020 book, *Governance of Offshore Freshwater Resources*, "ground-breaking," "important," and "creative." She has given presentations on water-related topics at the IWRA World Water Congress, Stockholm World Water Week, International Association of Hydrogeologists Congress, American Water Resources Association Groundwater Conference, World Bank

Law, Justice and Development Week, Dundee International Law and Transboundary Freshwaters Workshop, International Law Students Association Jessup Moot Court competition, and London Water Research Group Hydro-Hegemony Conference.
