Rick is a former Member of Stevens & Lee, where he served as the Chair of the Energy, Regulatory and Public Utilities Group and as a member of the Corporate Transactions and Financial Markets Practice Group.

Rick is the founder of the law firm of R. L. Hicks & Associates, where he provided legal and consulting services to governmental entities, public utilities, corporations, nonprofits, educational institutions, and cultural and religious organizations. He has substantial experience in public and private management, budget development and administration, legal counsel and instruction, client representation, litigation, and enforcement of state and federal laws.

Rick also previously served as Regional Vice President and Regulatory Counsel for XO Communications, Inc. and as Executive Deputy Attorney General and Director of the Public Protection Division within the Pennsylvania Office of Attorney General. He has served as a member of the Capital Area Regional Economic Development Commission, providing low interest loans to new and expanding businesses and as Chairman of the Pennsylvania Public Utility Commission's Consumer Advisory Council.
