REPRESENTATIVE MATTERS

- Represented a client defending against a motion to vacate a consent decree in state court. After a 44-day evidentiary hearing involving dozens of witnesses and hundreds of exhibits, the Eckert Seamans team obtained a favorable ruling.
- Represented a client in a FOIA lawsuit against two federal agencies in federal court. The Eckert Seamans team obtained a favorable result based on its sophisticated summary judgment briefing.
